


Total Population Jasper County

Change in proportion 1990-2000





Population Change: 1930-2000





Population Change: 2000-2007





Selected Vital Statistics








Per Capita Income: 2001-2006

Per Capita Income: 2001-2006 Percentage Change





Transfer Receipts: 2006 Jasper Co. Total = \$64,346,000





Persons Living Below the Poverty Level 2007 Model-Based Estimates









Selected Employment Comparisons by Industry: 2007






Retail Sales Analysis: 2007 Jasper Co. Total Retail Sales = \$58,619,000
