As a general rule, most requests are handled within three business days...we look forward to assisting you in securing your filming location and necessary permits.

1. Contact Camera Ready Liaison.
2. Submit request detailing information and desired filming location.
3. Camera Ready Liaison will assist in contacting site/location owner/representative and will set up the initial meeting between filming company and owner/representative.
4. Camera Ready Liaison will submit permit application to Jasper County Commissioners (City of Monticello Council or Town of Shady Dale Council) for approval. \$250.00 permit fee to be submitted with request. Permit is valid for 90 days.
5. Camera Ready Liaison will contact Sheriff's Agency if road closures or security are needed. You will be assigned a contact from the Agency. Off-duty officers will charge by the hour and are paid by the filming company.
6. The Camera Ready Liaison will provide maps of the county, list of restaurants, businesses, etc. about the local area and will assist in finding or suggesting locations.

**THIS APPLICATION MUST BE APPLIED FOR THREE (3) BUSINESS DAYS PRIOR TO SHOOT**

**FEE: \$250.00 (valid for 90 days)**

No person shall use any public or private property, building, facility, or residence of producing, taking or making any motion picture, television production or photographic production without first applying for and receiving a Media Production Permit.




